### Features

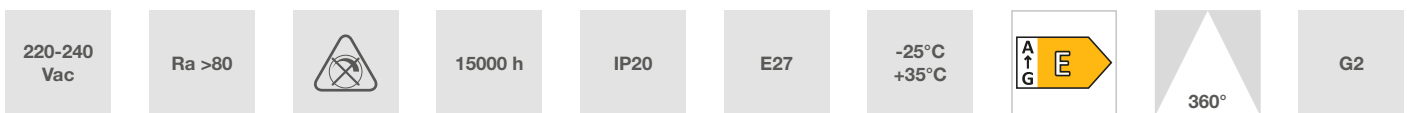
